## Local Service Tax Update

On September 20, 2016 Rockwood Borough Council passed a Resolution to appoint Capital Tax Collection Bureau as the Agent to collect, administer and enforce the Local Service Tax imposed and assessed by Ordinance #07-03 dated November 20, 2007. This will be in affect beginning January 1, 2017. Sometime before the end of this year, businesses in the borough will be receiving letters from Capital Tax. They shall also collect all delinquent Local Service Tax beginning January 1, 2017 for any and all delinquent Local Service Tax, regardless

# **BURN PERMIT**

If you are planning to burn any yard debris, leaves or other things during your yard cleanup, you **must** obtain a burn permit from the Borough Office. According to Rockwood Borough's Burn Ordinance No. 92-3, the only thing allowed to be burned is yard debris. lease note, items such as tires, construction materials, garbage, rubbish, etc. is prohibited. The cost of a permit is \$10.00 per day and can be obtained at the Rockwood Borough Office at 669 Somerset Avenue.

# WINTER PARKING

On Broadway, parking will **only** be allowed on the lower side (even numbered) of the street for the entire winter season. There will be **no parking** allowed on the upper side (odd numbered) of the street during the entire winter season. This will hopefully help residents avoid confusion as to which side to park on as in years past. This policy is in effect from November 15th through March 31st. Failure to comply may result in you being plowed in and/or receiving a parking ticket. The Borough **will not** be responsible for damage to mailboxes or personal property on the Borough's right-of-way, which is 16 1/2 feet each way from the center of the road. With an 8 foot plow, it is VERY IMPORTANT that we adhere to this policy, otherwise, it may be impossible for the employees to be able to properly plow the streets if there are vehicles parked on both sides of the street at the same time.

Also, just a reminder that throughout winter, there will be no parking on Main Street from

3:00 am - 6:00 am.
