RESOLUTION

It is resolved by the Council of the Borough of Rockwood that it is appropriate to establish various rates from time to time pursuant to the authority of Rockwood Borough Ordinance No. 2014-1, commonly referred to as the Rockwood Borough Water Ordinance, and Rockwood Borough Ordinance No. 1993-2, as amended, commonly referred to as the Rockwood Borough Sewer Ordinance.

Accordingly, it is Resolved and is hereby Resolved by Rockwood Borough that the following rates are hereby established as of March 1, 2014 pursuant to the terms of the Rockwood Borough Water Ordinance and the Rockwood Borough Sewer Ordinance.

Therefore, it is Resolved as follows:

- 1. The penalty for delinquent payments shall be .0083 multiplied by the outstanding amount.
- 2. The "third party tester" for disputed meters shall be EAP Industries, Inc.
- 3. The fee for turning on service which had been shut-off shall be Forty and 00/100 (\$40.00) Dollars for each service of water and sewer.
- 4. The specification for piping shall be 3/4ths-inch lead-free copper pipe.

- 5. The general rates for water and sewer service shall be as follows:
- A. In Rockwood Borough:
 Water \$20 minimum billing, plus .0047/1,000 gallons
 Sewer \$20 minimum billing, plus .0047/1,000 gallons
- B. In Black Township:
 Water \$20 minimum billing, plus .0047/1,000 gallons
 Sewer \$24 minimum billing, plus .0047/1,000 gallons
- C. In Milford Township:
 Water \$20 minimum billing, plus .0047/1,000 gallons
 Sewer \$24 minimum billing, plus .0047/1,000 gallons
- 6. The "tap-in" fees for service inside the Borough shall be Eight Hundred and 00/100 (\$800.00) Dollars, each, for water and sewer, and for service outside the Borough shall be One Thousand Eight Hundred and 00/100 (\$1,800.00) Dollars, each, for water and sewer.
- 7. The inspection fee shall be Forty and 00/100 (\$40.00) Dollars for each service, water, and sewer.
- 8. The fee to shut-off service in order to obtain an exoneration shall be Forty and 00/100 (\$40.00) Dollars for each service, water and sewer.

It is further resolved that the above items shall be effective as of March 1, 2014, and Rockwood Borough reserves the right, pursuant to the various provisions of the relevant Ordinance to modify or change any of

the above items, individually, collectively, or in any groupings which the Council of the Borough of Rockwood may determine from time to time to be appropriate by further and future resolution.
