Meeting Minutes

September 19, 2023

Attorney Carroll spoke about the Roberta Miller property on Broadway. He spoke with Steve Spokart that week and was told that the County Commissioners must earmark the money for these blighted properties. Attorney Carroll is going to contact Ken Carolus to see if he still intends to buy that property.

Under new business a motion was made by Samantha Bartko to pay the monthly bills. Mike Hutchison seconded the motion. All were in favor. Samantha Bartko made the motion to approve the change order from Darr Construction. The change order will cover the recessed lighting and electrical portion of the park to make sure it is up to code. The change order amount is \$1250.00.

Samantha Bartko made a motion to amend the agenda in accordance with Act 65 of the Sunshine Act, and place the previous three motions on the agenda. Nancy Sleasman seconded the motion. All were in favor.
